#### Non-compliance with the accessibility regulations

- Some of our PDFs are not currently accessible. They are not tagged properly, they do not have clear and correct titles and not all of our images have

alternative text. This makes them difficult to read with a screen reader and for keyboard-only users. (WCAG 2.4.2 Page title, WACG 1.1 Text alternative, WCAG 1.4.1 Use of Colour, WCAG 2.1 Keyboard Accessible). We are working as quickly as possible to fix these issues in priority order and plan to complete this work by October 2021.
